A \$600 per person cancellation fee will be charged if received in writing 60 to 100 days prior to departure. Cancellations made in writing within 60 days prior to departure are subject to a \$600 per person charge plus any nonrecoverable land/air package charges. Airline tickets once purchased are non-refundable but may be used for future travel on that airline within one year.

Not included in price: All items not specifically listed under tour features.

Insurance: Trip cancellation, baggage, health and accident insurance is available on request and is highly recommended to all participants.

Passport: You must have a valid passport and electronic visa (visa is free of charge).
