Rates: Air and Land Prices may change due to currency fluctuations or changes in the tax.

The initial deposit for Rwanda is non-refundable if canceled at any time once confirmed. No refund applies to cancellations after April 1. If a substitution is found, only a \$500 cancellation fee will be charged (applies only to Lewa).

Not included in price: All items not specifically listed under tour features. A payment of \$50 must accompany the visa application. Game Park fees are subject to change. At present \$50 per person for the Ark and \$70 per person per day at the Masai have been included. If pricing changes, individuals will be responsible for paying the difference at the hotels.

Insurance: Trip cancellation, baggage, health and accident insurance is available on request for residents of the U.S. and Canada and is highly recommended to all participants. Residents from other countries must check within your country for availability of insurance coverage.
