GENERAL CONDITIONS

Rates: Air and Land Prices may change due to changes in any taxes. There is also a possibility of a fuel surcharge that is dependent on the cost of fuel about 4 months prior to departure.

Reservations and Payments: A completed tour application together with an initial deposit of \$300.00 per person which is refundable. This will hold a spot. An additional deposit of \$2000 per person must be received before April 1, 2010 before confirming reservations on a definite basis for 2011. A third deposit of \$2000 is due August 1, 2010. The balance of payment is due November 1, 2010.

Cancellations: A full refund of initial deposit of \$500 will be made if cancellation is received in writing before June 1, 2010. A \$2300 per person cancellation fee will be charged if cancellation is received in writing after June 1, 2010 and before August 1, 2010. A \$4300 per person cancellation fee will be charged if cancellation is received in writing after July 30, 2010 and before November 1, 2010. No refund applies to cancellations after November 1, 2010. If a substitution is found before November 1, 2010, only a \$500 cancellation fee will be charged. Airline tickets are non-refundable once issued.

Not included in price: All items not specifically listed under tour features. A reciprocity tax is charged on arrival for passport holders of the US (\$131USD), Canadians (\$70USD) and Australians (\$100USD). A departure tax of about \$5 is collected when departing Ushuaia and \$18 when departing Buenos Aires. Any new tax imposed by any government agency. All taxes are subject to change. The entry fee of \$200 for either event is additional. Any fuel surcharges assessed by the cruise company.

Insurance: Medical evacuation insurance is mandatory for all passengers. Trip cancellation, baggage, health and accident insurance is highly recommended for all participants. Residents from outside the U.S. must check within your country for insurance coverage.

If the event is not held, I understand that no refund of my travel expenses or entry fees will be reimbursed.

The right is reserved by Marathon Tours, Inc. to deny acceptance of a booking application by any person. Marathon Tours, Inc. may make any changes or alterations in the itinerary as it deems necessary for the proper handling of the tour. The sole responsibility of any airline used is limited to that set out in the passenger contract evidenced by the ticket.
