GENERAL CONDITIONS

Rates: We can quote airfares to Bermuda from all cities. Call 800-444-4097 or 617-242-7845 from 9am-5pm EST for a quote.

Reservations and Payments: A completed tour application together with a deposit of \$100.00 per person must be received before confirming your reservations. Final payment must be received before December 1, 2010.

Cancellations:

Airfares: Airline tickets are non-refundable once ticketed but may be exchanged for future travel on the same airline if a new reservation is made and paid for prior to the departure date of the original ticket.

Hotel Packages: Cancellations made in writing for hotel packages before November 2 are subject to a \$50 per person handling charge. Cancellations for hotel packages made in writing after November 1 and before December 1 are subject to a \$100 per person charge. No refund applies to cancellations made for hotel packages after December 1. Any unused features are non-refundable.

Not included in price: All items not specifically listed under tour features. All race entries must be sent directly to the Bermuda Track & Field Association with the appropriate entry fee or you can enter online.

Insurance: Trip cancellation, baggage, health and accident insurance is available on request and is highly recommended to all participants.
