Cancellations:

Hotel Packages: Cancellations made in writing for hotel packages before May 1 are subject to a \$500 per person handling charge. No refund applies to cancellations made for hotel packages after May 1. Any unused features are non-refundable. Airline tickets once purchased are non-refundable.
